Hello and welcome! Thank you for allowing your son/daughter to volunteer for us! We really appreciate the help on busy adoption days! And so do the kitties!

Our adoptions are normally held on the weekends at the Oviedo PetSmart. Some weeks we are there both Saturdays and Sundays and other weeks we are just there Saturday. When we are there both days our hours are 10-3 (Setup starts at 10) on Saturday and 10-3 on Sunday (Breakdown can start anytime from 2:30-3:00). If we are only doing Saturday then our hours are 10-3 with breakdown starting at 3. We ask that if they commit to stay until the end of the day that they stay until everything is packed up.

On Thursdays one of our volunteers will be sending a group text message. All of our volunteers also work full time jobs, so please be patient if it does not come at the same time each week. We ask that the student needing bright future hours respond to this text if they can work that weekend or not and what hours they can be there. This is very important so we can plan the schedule for the weekend.

Inside PetSmart there is limited cell service because of how the building was built. If you cannot reach your son or daughter while there please try texting Jessica (305-394-3287) and if she is in the same dead spot please call PetSmart and ask to be given to cats-can.

This is an excellent opportunity for the student to learn responsibility. It can be chaotic at times, but this volunteer opportunity allows them to speak with many different people and allows them to experience working with other people who have the same goal...get kitties adopted!
